- a) Complaints report to consider the following recommendations from the complaints report received at the Parish Council meeting held on 25<sup>th</sup> January 2023
  - i. That the Chair does not act alone unless it has been resolved to do so.
  - ii. That overzealous applications of confidentiality and data protection is not applied, and that clarification is sought in this area. (See attached notes on confidentiality and 'need to know')
- iii. That APC, within its Standing Orders, creates a Complaints Committee, members of which should not be the Chair of either full council or the staffing committee. (Previously resolved at January 2023 meeting)
- iv. That the Chair of APC should not be a member of the staffing committee as this does not leave an appropriate, fully independent member of council to hear appeals in employment issues that are the remit of the staffing committee.
- v. That clarity be sought in the advice given by YLCA in the conducting of preliminary fact-finding investigations as there seems to be some variance in the advice given by ACAS in its guidelines. This is in reference to concurrency of disciplinary processes. (APC Disciplinary procedure attached)
